#### ABOUT THE SCEDC

#### ABOUT THE 2010 BUSINESS RETENTION SURVEYS

In 2010, a total of 107 companies were visited throughout Sheboygan County, representing many of the major employers or key community businesses. Most were visited during a condensed 45-day survey blitz organized by the SCEDC in September and October. During this time period, multiple state-wide elections were in full swing and the national debate regarding healthcare was at its zenith. These events likely influenced responses during 2010.

Sheboygan County is located within the 18-county *The New North* region. Economic development organizations from throughout this area perform similar business retention survey outreach efforts, and utilize a shared online software program - Executive Pulse - to analyze survey results.

The 133-question survey includes sections on: company profile, local workforce, sales, e-commerce, facility and equipment, municipal services, and business climate. A regional comparison of 2010 summary responses follows.

- ▶ 62% of firms have a strategic plan

- ▶ 48% of firms have increased their IT investment over the past 18 months
- ▶ 16% of firms sell directly to government
- ▶ 18% of firms import materials from other nations
- ▶ 31% of firms export products to other nations
- ▶ 57% of firms use the internet to sell products
- ▶ 61% of firms use the internet to buy products
- ▶ 67% of firms have a formal workforce training program
- ▶ 76% of firms indicated that the majority of essential personnel were middle-aged
