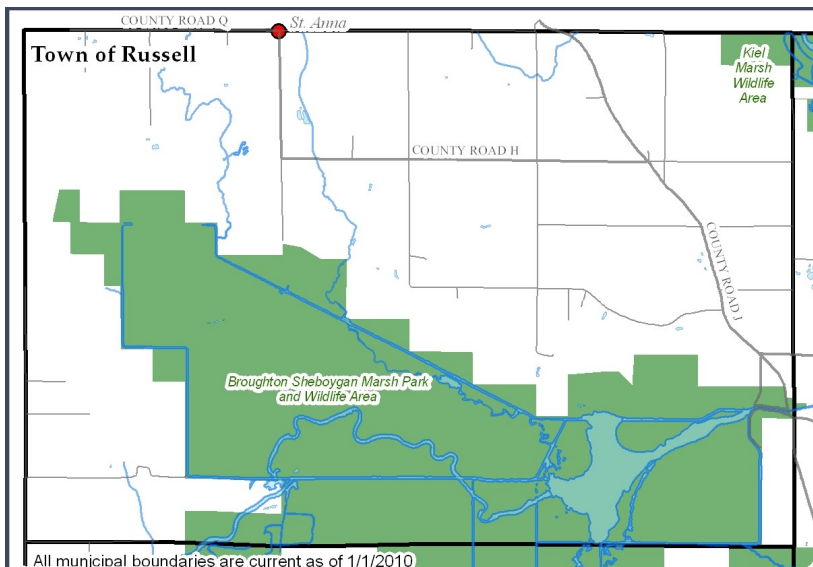




Town of Russell, WI

ECONOMIC PROFILE

The Town of Russell is located in northwestern Sheboygan County, along the Calumet and Fond du Lac County borders. The Town of Russell is a rural community, predominately farmland with open/green space, single-family residences, and a quality natural resource base. The Town includes the hamlet of St. Anna. The Town is home to the Broughton Sheboygan Marsh Park and Wildlife Area and the Kiel Marsh Wildlife Area.

UTILITIES

WATER & SEWER

The Town of Russell does not have a public water or sewer system. Residents within the Town have individual wells and individual septic systems that are owned and maintained by individual property owners.

TELECOMMUNICATIONS

Landline phone service is provided by Verizon North. Broadband internet is offered by Time Warner Cable where available.

TRANSPORTATION

The Town is not intersected by any state highways. Rail service is not available. Sheboygan County Memorial Airport (SMB) is 19 miles away.

HOUSING

Using 2000 Census data, the median housing value in the Village was \$98,300 and is lower than the median housing value of the entire County.

BUSINESS PARKS

Currently there are no business parks in the Town of Russell, nor are there any future plans for a business park. The Town of Russell will seek to steer most commercial activities toward St. Anna, Elkhart Lake, Kiel, and Glenbeulah. The Town will continue to allow home-based businesses and scattered types of businesses that provide needed services to locals. The Town is heavily dependent on its farming economy.

The Town's median household income in 1999 was \$51,250, which was higher than the State and Federal median household income.
